A public hearing will be held by the Town Board, Town of Veteran, Chemung County, New York on Nov. 15, 2018, at 6:50 at 4049 Watkins Rd., Millport, NY, for the purpose of considering a new contract for the years 2019 with Town & Country Fire Dept., said contract shall be for fire protection to the Town of Veteran Fire Protection District No. 3, said new contract to be upon the following general terms:

- a. Town & Country Volunteer Fire Dept. shall answer and attend all fire calls in said District.
- b. For such services, Town & Country shall be paid the sum of \$72,944.68 for the year [dollars].
- c. Town & Country Fire Dept. shall maintain and operate fire stations at Horseheads, NY.
- d. Each fire company shall insure all of its equipment against all liability and shall protect the Town of Veteran from liability for any accident in which any fire company vehicle may be involved.
- e. The contract shall continue until December 31, 2019.
- f. Such other incidental terms as may be necessary or proper.

A public hearing will be held by the Town Board, Town of Veteran, Chemung County, New York on Nov. 15, 2018, at 6:55 at 4049 Watkins Rd., Millport, NY, for the purpose of considering a new contract for the years 2019-2021 with the Village of Millport and Millport Volunteer Fire Company, Inc., said contract shall be for fire protection to the Town of Veteran Fire Protection District No. 1, said new contract to be upon the following general terms:

- a. Village of Millport and Millport Volunteer Fire Co., Inc. shall answer and attend all fire calls in said District.
- b. For such services, Village of Millport shall be paid the sums of \$56,511.77, \$57,642.01, and \$58,794.85 respectively each year and Millport Volunteer Fire Co., Inc. shall be paid the sums of \$18,873.26, \$19,214, and \$19,598.28 respectively each year [dollars].
- c. Village of Millport shall maintain and operate fire stations at Millport, NY.
- d. Each fire company shall insure all of its equipment against all liability and shall protect the Town of Veteran from liability for any accident in which any fire company vehicle may be involved.
- e. The contract shall continue until December 31, 2021.
- f. Such other incidental terms as may be necessary or proper.
